## Booster Club Bylaws Treasurer description

Section 8. Treasurer: The Treasurer shall: (a) have charge and custody of and be responsible for all funds and securities of the Club; (b) receive and give receipts for moneys due and payable to the Club from any source whatsoever, and deposit all such moneys in the name of the Club in such banks, trust company or other depositories as shall be selected in accordance with the provisions of Article V of these Bylaws; (c) be responsible for assuring that an annual audit is conducted by the Trustees prior to the annual meeting; and (d) in general perform all duties of the office of Treasurer and such other duties as from time to time may be assigned to him or her by the President or by the Board of Directors.

## Job Duties

- <u>Withdraw and prepare all change for events which includes tally sheet, deposit slip</u> and deposit bag for night deposit
- Notify bank weekly of cash needs
- Drop off change for each event with opening concessions board member
- Help close concessions if no board members are available
- <u>Check booster mailbox twice weekly and deposit any incoming checks</u>

- <u>Reconcile and pay monthly Booster club credit card statement (accounting for all receipts)</u>
- Maintain and be available for all Square or WePay card reader issues
- <u>Categorize income for annual Auction</u>
- <u>Categorize income from Benevity donations</u>
- Provide receipts for donations not provided by Auctria
- Pay any approved team expenses and scan receipts into QuickBooks online
- <u>Provide copies of monthly financial reports to board members at meetings and copy to</u> <u>Booster Google drive</u>
- Maintain Concessions income google sheet for cash and credit card payments
- Pay out Fall, Winter and Spring concessions team earnings to high school
- Daily check and categorize QuickBooks online transactions
- Work with Sherwood Accounting and Tax to prepare taxes each spring
