1. Approval of previous meeting minutes- Approved

2. Guests – None
3. Coaches Request –
  1. Girls Volleyball – Jenette Brotnov as present. Been 3 years since we did Jerseys. Requesting 3 sets for a total of \$4,742.03. Cori motioned to approve the full amount of \$4742.03 for jerseys and Keri seconded, the motion passed.
  2. Dance Team – Trisha Herndon was present to discuss her dance team budget. There is a \$19,000 deficit in the budget. She is asking booster club to see what they might be able to donate and brainstorm ideas to come up with funds.
4. Treasurers report- Jennifer, stated that revenue is slightly down and this is primarily due to concessions' income being lower this year. We saw fewer games this year, fewer volunteers to support operation, higher food costs due to inflation and tariffs, all of which impacted performance. The auction remained very strong this year. Total auction revenue came in at approximately \$94,700 compared to \$101,500 last year. The expenses decreased from \$38,000 last year to \$24,000 this year. This resulted in higher net efficiency and an overall net profit increase from approximately \$63,600 last year to about \$70,900 this year. cash balance as of 5/12/26 was \$122,139.59.
5. Concessions Report –The hot water heater for concessions has been ordered.

8. Stadium Report – Cami-No updates. Jon said the booster will donate a few seats to the Band auction and band will donate a basket for the booster club auction.

10. Sponsorship - Becky stated she has cleaned up the spreadsheet of the sponsorship list. A discussion was held about starting to work on getting sponsors for the auction in June/July
